- 1. **ELECTION OF CHAIRMAN:** Clir. Boddy proposed that Clir. Hopwood be re-elected to the Chair. This was seconded by Clir. Rogers. **This was unanimously agreed.**
- 2. ELECTION OF VICE CHAIRMAN: Cllr. Hopwood proposed that Cllr. Rogers be re-elected as Vice-Chairman. This was seconded by Cllr. Isherwood. This was unanimously agreed.

4. APOLOGIES FOR ABSENCE: None

5. MINUTES OF THE MEETING held on 21 April, having been previously circulated, were confirmed as a correct and signed by the Chairman.

6. CHAIRMAN'S ANNOUNCEMENTS

(Action by)

- T. Jolley's letter of resignation has been accepted. This creates a casual vacancy on the Parish Council. The Clerk was asked to ensure this was an agenda item for the next Parish Council Meeting and Clirs. agreed to canvass for nominations for the vacancy.
- A letter from Computashare has revealed an investment of £28.49 in War Gilts. Cllrs. agreed these should be sold and proceeds transferred to the bank account. (CD)
- Clirs. agreed Clir. Bingham should take up the matter of the way CCC is handling the unsatisfactory state of Burton's Main Street pavements (County Clir.RB)
- Cllr. Willink proposed that Cllr. Hopwood be nominated Parish representative on the CALC Executive Committee. This was seconded by Cllr. Alderson and unanimously agreed (JH)
- Cllr. Isherwood agreed to attend the Lancaster Canal Trust AGM on 24 May 2005.

• A parishioner queried the wording of an article in the Lake District Life about Burton stated that a site for affordable housing had been earmarked by SLDC. In fact SLDC have only identified a possible site at this stage. Clirs. agreed that the word 'earmarked did not imply a certainty. The magazine went to print prior to the Village Meeting. The Chairman thanked Kath Hayhurst for providing the reporter with historical information about the village.
