- **2. MINUTES OF THE MEETING** held on 15 June, having been previously circulated, were confirmed as correct and signed by the Chairman.

# 3. CHAIRMAN'S ANNOUNCEMENTS

(Action by)

- J.Alderson was welcomed back as a co-opted councillor to fill the gap left by B.Willink.
- The proposed fenced footpath alongside the A6070 between Burton & Clawthorpe will not go ahead because of objections from a tenant affected by the proposal. Cllr.Boddy suggested the existing verge could serve the same purpose if it was kept cut by a lengthsman
- CCC has invited the parish council to write expressing interest in applying for a funded lengthsman by
   11 August. This will be dealt with by the Chairman & it will be an agenda item for August (CD)
- Clirs. were asked to note that the public consultation for NHS acute medical services is in the circulation file and CCC invites responses by 13 September. In the meantime public meetings have been convened (6.30pm at RLI Lancaster 24 July & 6.30pm at Kendal Town Hall 25 July). The Clerk was instructed to put this onto the August agenda.
- In the absence of PC Suart the Police Report was read out
- As there are so many planning applications and interested members of the public, for this meeting the latter would be invited to make their representations under agenda item 5 at the appropriate time.

**SL/2006/0669** – 19 Morewood Drive, Burton – Single storey rear extension for Mr & Mrs Wilson. (The Council had received one letter of objection.) **No objections, but Clirs.expressed their concern that the development should respect the concerns of neighbours.** 

**SL/2006/0694** – 17 Hollowrayne, Main Street, Burton – Extension & alterations for Mr & Mrs Steele. (Cllr.Rogers declared a personal interest.) **No objections.** 

**SL/2006/0751** - 32 Morewood Drive, Burton – Two storey rear extension for Mr A.Barker. (Cllr.Rogers declared a personal interest.) Photographs were circulated and a case put by neighbours who objected. Cllrs unanimously strongly objected to the overbearing nature of the development.
