1. APOLOGIES FOR ABSENCE: None

2. **MINUTES OF THE MEETING** held on 21 July, having been previously circulated, were confirmed as correct and signed by the Chairman after the following changes:- Item 6 to read 'Cllrs. agreed an increase of £41.02 on Panorama commitment per Cllr.Willink's request – this is recoverable VAT'. • SL/2005/0863 – Former Burton Garage, Church Bank, Burton. Revised scheme to plots 1-7 of original planning application SL/2004/0459 for Norman Jackson Builders. Councillors objected by a majority of 5 to the application on the grounds that it turned what were two storey dwellings into three storeys high, making it an overbearing development and unneighbourly in this situation.

Cllr. Boddy wished it to be noted that he voted **not** to object to the application.

• **SL/2005/0334** – Coppers End, Tanpits Lane, Burton. Appeal lodged by Mr.P.Wearing regarding refusal of planning permission for first floor extension

# 12. Quality Parish Assessment Report

 The Chairman announced that Burton News did not wish to quote for printing a regular quarterly Parish Newsletter. Two quotes were received – Stramongate Press, Kendal quoted £82 per quarter and Cypher of Milnthorpe quoted £165 excluding VAT. Both will be asked to re-quote on a prepared mock-up.

## 13. REPORTS

- Cllr.Rogers explained he had replied to requests for feedback from Lancaster City Council and SLDC regarding their Local Development Framework Submission Statements of Community Involvement, as agreed at the meeting last month. In both cases they were mainly in plain English but tended to be too long. He also reported that the telephone booth at Clawthorpe had now been removed, Caterpillar Walk verges had been mown and that he & his son would attend to overgrown stiles and fix waymarkers in the parish, as required.
- Cllr.Mason-Hornby reported that damage to oak trees on Tarn Lane was not serious and may have been caused by hares
- Cllr.lsherwood reported that the school is proposing to replace the railings around the site. He agreed
  to submit a sketch of the proposal to the next Parish Council Meeting

Cllr.Boddy reported the AGM of the Burton Recreation Trust has now been scheduled for 31 August

• Cllr Aldren reported the mound at the junction of the Kirkby Lonsdale/Arkholme road had been attended to Alderon in
