Minutes of the Annual Parish Council Meeting held on Thursday 15 May 2008 at 7.00 pm in the Memorial Hall, Burton-in-Kendal

PRESENT: Cllrs. R. Boddy, J.Brown, J.Hopwood G.Isherwood, R.Lawson, F.Mason-Hornby, P.Rogers, A.Wren, R.Bingham (District Cllr.) C.Dale (Clerk).

IN ATTENDANCE: Four members of the public.

- 1. ELECTION OF CHAIRMAN: Clir.Lawson proposed that Clir. Mason-Hornby be elected to the Chair. He was seconded by Clir.Brown. This was unanimously agreed. The new Chairman thanked the Clir.Rogers and all his predecessors for all the work they had put in as chairmen in the past
- 2. ELECTION OF VICE CHAIRMAN: Clir.Hopwood proposed that Clir.Boddy be elected as Vice-Chairman. This was seconded by Clir.Isherwood. This was unanimously agreed.

3. ELECTION OF REPRESENTATIVES:

- Burton Recreation Trust Cllr.Boddy agreed to take over the role from J.Alderson and Cllrs. unanimously confirmed the appointment.
- CALC Cllr.Rogers announced he was willing to continue and Cllrs.agreed a second ad hoc representative could be appointed during the year as required
- Memorial Hall Committee Cllr.Brown volunteered to take over from Cllr.Wren and this was agreed
- Quarry Liaison Committee Clir. Hopwood and Clir. Wren volunteered and this was agreed
- School Governors Cllr.Isherwood volunteered and this was agreed
- Burton Education Foundation The Clerk was asked to Invite Mrs K. Unsworth to continue to represent the Parish Council
- Boon Town Playing Ground Cllr.Wren volunteered and this was agreed
- Christmas Trees & Lights Cllrs.Lawson and Wren volunteered and this was agreed
- Lengthsman Administrator Cllr.Rogers volunteered and this was agreed.
- Plain Quarry Cllr.Hopwood volunteered and this was agreed
- Parish Newsletter Editor It was agreed this appointment be deferred to the next meeting

4. APOLOGIES FOR ABSENCE: District Clir, B.Cooper

- 6. DISCUSS VACANCY ON PARISH COUNCIL: It was unanimously agreed the Clerk would advertise for a councillor with a closing date for applications of 19 June 2008 (CD)

7. CHAIRMAN'S ANNOUNCEMENTS

- Request for support from Skipton–E.Lancs.Rail Action Partnership for petition to reinstate line to Skipton. This was deferred to the next meeting and the item placed in the circulation file
- A final call from SLDC to comment on their website on the Local Development Framework 'Preferred Options' by 30 May. The website address was read out and the letter was placed in the circulation file.
- A suggestion from members of the public to name the new housing development at Boon Town 'Masons Park'. This was deferred to the next meeting and the item placed in the circulation file

8. OPEN FORUM - Points raised:

- A suggestion from members of the public to form a fund raising group for play equipment on Boon Town Playing Ground was discussed in conjunction with the letter received from NPS (see Item 14 below) that was read out by the Chairman. It was agreed that it would be beneficial for the group to work together with the Parish Council on this in future
- Cllr.Rogers declared a prejudicial interest in SL/2008/0364 (see Item 9 below) and expressed support for this as a member of the public in recognition of the owners past work in restoring the property

SL/2008/0364 – Shoemaker Cottage, Neddy Hill, Burton – Replacement windows to front elevation for B.Clarke. Cllr.Rogers declared a prejudicial interest and left the room. Cllrs.objected to the style and UPVC materials proposed for these windows but had no objection to the application if executed with wooden window frames in a more sympathetic style SL/2008/0367 – Hutton Roof Sawmills – Extension to sawmill for P.Irving.

Cllrs.unanimously supported this application

SL/2008/0429 – Barklee, Vicarage Lane, Burton – Single storey garage & front entrance extensions for S.Head. No objections

SL/2008/0438 – Cornmillers Cottage, Coat Green, Burton – Sun room/conservatory for F.Watson. Clir.Mason-Hornby declared a prejudicial interest and left the room. No objections

- Cllr.Rogers noted that CCC had today marked Clawthorpe Lane for repairs. The Clerk was instructed to write to lan Stewart of CCC asking for the schedule of visits planned by CCC Highways Steward (CD).
