 - **ii. SL/2013/0215** 7, Thornleigh Drive, Demolition of existing bungalow and construction of replacement dwelling, as amended.

 - i. **SL/2013/0273** Storth Ltd, Burtlands Farm, Erection of detached B2/B8 building and construction of service yard.

 - i. SL/2013/0429 10 Thornleigh Drive, Two storey rear extension for Mr and Mrs Swindell.
 - **ii. SL/2013/0401 (Lancaster 13/00476/FUL)** Burton Motorway Services, Erection of single Wind Turbine (70m to blade tip) with associated access and infrastructure. (Item 11 may be considered concurrently with this application).
 - **iii. Lancaster 13/00494/FUL** Greenlands Farm, Erection of single Wind Turbine (35m to blade tip).
 - iv. SL/2013/0421 Green Dragon Farm, Erection of three Wind Turbines (34.4m to blade tip). (To be considered only if formal consultation received.)
 - **iv. SL/2013/0457** Burton Morewood School, Alterations and extensions to the infant block. (To be considered only if formal consultation received.)

- **9.** To consider the public response to the article in Burton News on neighbourhood Planning and to decide if the Council wishes to lead and encourage the community to produce a Neighbourhood Plan with the aims of:
 - **a.** Defining the character (but not the extent) of development within the Parish.
 - **b.** Deciding what community facilities would be needed to support the village in the future.
 - **c.** Deciding what infrastructure changes would be necessary to improve the village in the future.
- **10.** To decide how to respond to the County Council's proposals for the repair of Slape Lane. Noting that the County Council is proposing a 2-3m wide bridle way, constructed with graded stone, and is seeking to persuade the Parish Council to part fund the work.

- 11. To note the letter from Seren Energy Ltd giving details of the community fund payments they intend to make if the wind turbine at Burton Motorway Services is built. (This item may be considered as part of Item 6c at the Chairman's discretion.)
- **12.** To decide if the Council should set up a Budget Working Party to develop the budget for FY 2014/15.
- **13.** To consider the maintenance of the triangle of land at the junction of Station Lane and Tanpits Lane and to decide if the ground should be cleared and grassed over.

- **15.** To review Lengthsman's weekly logs on the Playground and to receive reports from Parish Councillors, District Councillors and the Clerk.
