Minutes of the Parish Council Meeting held on Thursday 15 December 2005 at 7.30 pm in the Memorial Hall, Burton-in-Kendal

PRESENT: Cllrs. J.Hopwood (Chairman), R.Boddy, G.Isherwood, R.Lawson, P.Rogers, A.Wren, K.Ray, B.Willink, R.Bingham (District Cllr.) C.Dale (Clerk).

IN ATTENDANCE: Twelve members of the public.

1. APOLOGIES FOR ABSENCE: Cllr. F.Mason-Hornby

2. MINUTES OF THE MEETINGS held on 17 November, having been previously circulated, were confirmed as correct and signed by the Chairman after the following amendments were agreed:- Cllr.R.Lawson was present. Under item 3 'Cllr.Lawson was formally welcomed by the Chairman'. Under item 11 'Cllr.Mason-Hornby reported six cars parked on the pavement outside the Memorial Hall at about 8.00pm Wednesday 9th November 2005 in contravention of the Highway Code'.

3. CHAIRMAN'S ANNOUNCEMENTS

(Action by)

- Appeal for donations from CAB. Cllrs unanimously voted not to make a donation
- Appeal for donations from The Great North Air Ambulance Service. Cllrs unanimously voted not to make a donation
- CCC consultation questionnaire for the Kendal bus service survey. It was agreed the Clerk would write pointing out potential problems for parishioners travelling by bus to reach the hospital and railway station at Oxenholme from Kendal (CD)
- Invitation from the Cumbria Police Authority to add further comments to the questionnaire submitted in October with regard to amalgamation. Cllrs agreed there was nothing to add beyond saying that if the Home Office imposes one of the two options set out in the letter then Option 1 is preferred (i.e. merge Cumbria and Lancashire only) (CD)
- Letter to & from Impact Housing regarding affordable housing at Boon Town. Cllrs.agreed the Clerk should write to T.Whittaker at SLDC with a copy to B.Jackson requesting that the Council be sent a copy of the Section 106 Agreement when it is drafted and before any planning permission is granted (CD)
- Copy of enforcement notice on the Kings Arms from SLDC
- Announcement by Dalton Hall Estate & the Forestry Commission that Dalton Craggs is now open to the public
- 8 copy letters of objection to the proposed housing development at Church Bank sent to the Planning Dept. at SLDC. The contents of these was summarised

4. OPEN FORUM – Points raised: -

- PC Casson presented her Report for November that dealt mostly with cases of anti social behaviour. She also reported that a 2nd-hand radar gun is available for purchase for approximately £1,500 by interested parish councils to share
- Members of the public reported that when SLDC came to move the Station Lane street name they were intending to place it inappropriately on a Drovers Walk wall. Clerk was asked to ensure they returned with it and placed on a wall or verge on Station Lane (CD)
- The Chairman asked members of the public if they had anything to add to the objections to the proposed housing development at Church Bank. No further points were raised

5. PLANNING APPLICATIONS:

SL/2005/1243 – Outline planning application for a mixed development of affordable/open market value ho either for rent or sale on land at Church Bank, Burton for Mr J Simm. Cllrs. unanimously agreed with the pc in the copy letters and agreed to oppose the proposal

SL/2005/1277 – Renewal of permission for two-storey extension to rear of Old Hall Cottage, Tanpits Lane, Mr M Jackson & Ms A Berry. Cllrs. unanimously agreed to support the application

SL/2005/1317 – Illuminated signs for the Burton M6 Northbound Services for Travelodge. Cllrs. unanimously agreed they had no objections to the application

12. 'Wildlife Walk' at Burton Morewood School

A grant application has been made by Holme Park Quarry Liaison Committee to Cumbria Waste Management. The Wildlife Walk Project within the grounds of the school was described. Cllrs. agreed that the project was very worthwhile, both to the children and to the community and gave their unanimous support

13. REPORTS

- Cllr. Boddy reported Burton Recreation have written to Punch Taverns requesting action on car park at the Royal
- Cllr. Rogers reported Arnside Parish Council has become the first Quality Parish in the area. Also it appears an old stable has been converted to a dwelling at Burtlands. Clerk to report the matter to the Planning Dept. (CD)
- Cllr. Isherwood reported 35 houses are currently up for sale in Burton. Proposed a vote of thanks to Cllr. Rogers and Wren for erecting Christmas trees at the Memorial Hall. This was unanimously agreed. He also proposed the Quarterly Parish Newsletter be agreed by all the Cllrs. before it is printed. Cllr. Willink requested this should be put to the vote. The Chairman pointed out that printing deadlines made the logistics of this very difficult
- Cllr. Hopwood proposed a vote of thanks to Cllr. Rogers for preparing the December Quarterly Newsletter for distribution. This was unanimously agreed. She reported that the Quarry Liaison Committee still had a vacancy for another Parish Council representative. Cllr. Wren volunteered to join Cllr. Hopwood on the committee
- Cllr. Wren queried if anything had happened regarding the enforcement order put on Burtlands to unblock drainage holes from the road which do not yet appear to have been unblocked yet
- Cllr. Lawson reported 'unsuitable for heavy goods vehicles' signs in Burton confused heavy goods drivers trying to deliver goods to Dalton. Also rubbish has been dumped on land next to the football field and questioned whether a litter bin could be sited in the vicinity
