Minutes of the Parish Council Meeting held on Thursday 20 August 2009 at 7.30 pm in the Memorial Hall, Burton-in-Kendal

- 3. MINUTES OF THE MEETING HELD 16 JULY: Having been previously circulated, it was unanimously agreed the minutes were correct. They were then signed and dated by the Chairman.
- 4. CHAIRMAN'S ANNOUNCEMENTS: None


- 5. OPEN FORUM The Chairman read out the Police Reports for July & August consisting of minor incidents and apologies for absence from PCSO Rachel Roberts. He then read out an email from a parishioner regarding the colour a neighbours roof tiles had been painted. Clir.Isherwood circulated a photograph. The Clerk was instructed to write to B.Jackson asking for his opinion as the responsible Planning Officer. (CE
- Clir. Hopwood reported issues raised by 2 parishioners at her 7pm surgery (a) concern that the lack of dog bins on the canal has not yet been addressed. The Chairman explained this was in hand with the Canal Trust and Waterways Board together with provision of seating on the Burton parish section of the canal. This person also said nothing had been done about maize in field with footpath to Slape Lane, also Slape Lane was a disgrace (see Item 13 below). (b) concern that the Burton Playing Ground be cut before delivery of new equipment. The Clerk was asked to contact Grasscare to attend to the matter.
- A member of the public complained of the state of the A6070 northwards from the Green Dragon. The Clerk was asked to report this onto the Highways Hotline (CD)
- Another parishioner queried a proposed increase of speed limits on the A6070 to the south of the village. The Chairman explained CCC were undertaking a review (with which the Parish Council has asked to be involved) & during discussions they had mentioned this ploy had worked elsewhere
- Another parishioner recommended anyone seeing speeding motorists report the registration notine.
   to the police.
- Another parishioner complained the trailer parked on Tanpits Lane is still causing an obstruction. Also the
  planting on the Triangle at the bottom of Tanpits Lane needs the Lengthsman's attention please. (PR)
- The Chairman then asked members of the public to withdraw whilst he updated Clirs.on applicants to date for replacement of the Clerk in October.

- 7. FINANCE: The Clerk reported the 09/10 Precept from SLDC of £10,375 had been used to open the new NatWest current account & presented a NatWest Mandate form to transfer a portion of this into an interest-bearing account.Cllr.Rogers proposed £7,500 be transferred to the Bonus Saver account (one withdrawal per quarter only). # 9. DISCUSS BUDGET WORKING PARTY PROPOSALS FOR 2010/11

Clerk circulated the working paper showing a proposed precept of £13,781 that would reduce reserves further from £5,249 expected at April 2010 to £5,000 by March 2011. After some discussion it was decided the budget would be placed on the September agenda for final agreement (CD)

#### 10. APPROVE ADVERTISING PARISH CLERK VACANCY AT £180 PER INSERTION

The Chairman explained this may not be necessary as some applications have now been received. He asked for approval in case it was decided necessary before the September meeting. Cllr.Rogers proposed approval, Cllr.Wren seconded and this was agreed unanimously

#### 11. AGREE COST OF WEBSITE PROPOSAL

The Chairman read out the quote from A.Nichols for a revised Parish Council website: Initial design & setup £480, plus a further £480pa for monthly updating & maintenance (payable at £40 per month in arrears). He explained this had been agreed last month and compared well with another quote received. Clir.Isherwood proposed this expenditure be approved, Clir.Hopwood seconded and this was agreed unanimously

#### 12. PROPOSED LOCATION OF BUS SHELTER AT SOUTH END OF VILLAGE

Cllr.Isherwood reported a meeting with Martin Elson on site where it was agreed the only practicable site for a bus shelter was at the existing bus stop outside the Green Dragon. Cllr.Wren proposed this location be agreed, Cllr.Rogers seconded and this was unanimously carried. It was also decided the bus shelter specification be agreed for ordering within the budget at the next Parish Council meeting (CD)

#### 13. SLAPE LANE

An email previously circulated to all Cllrs.from A.Bonacker offering £1,000 towards improvements to Slape Lane was considered. It was stated that this was totally inadequate for the purpose and that the responsibility for Slape Lane was with CCC not the Parish Council. Cllr.Rogers volunteered to respond to A.Bonacker with a request to hold the £1,000 for other more cost effective projects for the Parish Council that could begin next year.
