Minutes of the Parish Council Meeting held on Thursday 20 September 2007 at 7.30 pm in the Memorial Hall, Burton-in-Kendal

- 1. APOLOGIES FOR ABSENCE: Cllr. J. Alderson.
- 2. MINUTES OF THE MEETING HELD 16 August: Having been previously circulated, the minutes were confirmed as correct and signed by the Chairman.

#### 3. CHAIRMAN'S ANNOUNCEMENTS:

ACTION

- Comments invited from SLDC by 12 Oct. on Notice of review of polling districts & places: It was agreed this be placed in the circulation file for Cllrs.to respond to SLDC individually (All Cllrs.)
- Invitation received from CALC for another parish member to serve on their South Lakeland Standards
   Committee. Cllr.Isherwood volunteered and he duly signed the nomination form. This was
   countersigned by the Chairman, Vice Chairman & Clerk for returning to CALC (CD)

#### 4. OPEN FORUM - Points raised:

- Two Community Policewomen were welcomed to the meeting and they presented their Report, listing a number of minor incidents dealt with during the past month. Members of the public then gave details of further problems that had occurred and these were noted by them. They pointed out that all members of the public should contact them immediately on **0845 330 0247** of any incidents they wish to report.
- A member of the public raised concerns on planning application SL/07/0963 (for consideration in Item 5 below) and suggested Cllrs.visit the site behind the Square.

## 5. BUS SHELTERS

Cllr.lsherwood reported that alternative locations and sites to those put forward at the last Parish Council Meeting are still being investigated by the Working Party, together with costings and availability of appropriate funding. It was agreed these would be discussed at the next Council meeting (GI)

#### 6. PLANNING APPLICATIONS

Planning applications granted:

**SL/2007/0673** – Hall Gardens, Tanpits Lane – Slate canopy to street facing elevation for Mr D.W. Parsons

Planning applications received:

SL/2007/0665 – 2 East, The Square, Burton – Installation of satellite dish (retrospective) for A. Donegan. Cllrs.unanimously agreed they had no objections

**SL/2007/0963** – Croft House Barn, Burton – Conversion of stone barn to dwelling for Mrs R. Nelson. Cllrs. Boddy & Isherwood declared a personal interest. After further discussion Cllrs.voted by seven to one to strongly object to this application on the grounds of it being an overbearing development and unsympathetic design, being in a conservation area. In their view it would be a gross intrusion of privacy and they recommend the Development Control Committee pay a visit to the site to properly understand the Cllrs. concerns. **(CD)**

Burton earlier this summer was only fined £600 by the magistrates

Cllr.Lawson reported Ragwort on the motorway embankment. The Clerk was instructed to report this
to CCC Highways - also to request they unblock the drains in the copse near Clawthorpe (CD)

• Cllr.Mason-Hornby reported a number of night parties being held at Plain Quarry. He also suggested the foundry mould for the milepost currently being made is kept for possible future use. It was agreed the Clerk should ask Signpost Restoration if this could be arranged (CD)

• Cllr.Brown queried the progress of a speed indicator display being shared by Burton & other parishes. The Chairman stated that the County Council are still considering the proposal.
