- 2. MINUTES OF THE MEETING HELD 21 FEBRUARY: Having been previously circulated, the minutes were confirmed as correct and signed by the Chairman

3. CHAIRMAN'S ANNOUNCEMENTS:

- Nomination forms from SLDC for the May elections were distributed to Cllrs.by the Clerk
- The Parish Charter was launched in Kendal by CALC on 3 March. CALC will write to all Clirs asking them to adopt the Charter
- At the CALC District Association Meeting hosted by CCC in the County Offices in Kendal on the 6 March it
 was announced that the Areas Highways Team will concentrate their efforts in urban areas
- Parishes in the Lengthsman Pilot Scheme had a meeting with the Chief Officer of CALC on 6 March to give their views on the Pilot and CALC will continue to lobby for a similar scheme for the future
- Dianne Whitehead (South Lakeland Local Committee Area Support Manager for CCC) had a meeting with representatives of Burton, Holme & Preston Patrick Parish Councils on 17 March to explain the Highways Stewards Scheme. It was announced that wef 6 April all front line County Cllrs. will each have a budget of £10,000 pa to spend in their electoral division on highways related matters. (In the Open Forum section of the Annual Parish Meeting that preceded this meeting District Councillor Bingham pledged financial support from his own Highways Budget of £10,000 for 2008/09)
- An email was read out from a member of the public complaining about a large puddle on Station Lane. The Clerk was asked to reply, explaining that this is being dealt with by District Councillor Bingham who is chasing it up with CCC (CD)
- Apologies were read out from PC Suart as well as the Police Report for February and March
