- OPEN FORUM (chaired by Cllr Mason-Hornby: 5)
  - i) PCSO Martin Boak was in attendance and read out the Police Report. There were 2 incidents the first being a scooter stolen from Boon Town, found and returned. The second being a report of an object being dropped from the Motorway Bridge on Tarn Lane hitting and breaking a car
