1) APOLOGIES FOR ABSENCE

Apologies for absence were received from District Councillor Harvey.

DECLARATIONS OF INTEREST AND APPLICATIONS FOR DISPENSATION: 2)

MINUTES OF THE LAST PARISH COUNCIL MEETING HELD: 3) The previous minutes were approved and signed by the Chairman.

5) **OPEN FORUM**

- a) Three residents of Tanpits Lane area attended the meeting to put forward their objections and comments on planning application under Item 7d of the Agenda. These comments have also been sent direct to Development Management at SLDC.
- b) Representatives from Burton Recreation Trust attended the meeting to update the Parish Council on their fundraising and work at the MUGA. The new surface is completed and many groups and individuals are benefitting. However there have now been issues with unaccompanied children and therefore a controlled access system is required. More fundraising efforts are being made however the BRT asked the Parish Council to consider contributing towards the new Access Control System which will cost approximately £1000 to install. They also want to consider CCTV for the future but this needs to be researched due to new GDPR issues.
- c) Local Landowner informed the Parish Council of the arrow found on land as reported in the Police Report. This arrow was shown to the Councillors and looked extremely dangerous and was a concern.
- d) A resident informed the Council that following a meeting with Canal Trust she has been informed that a lengthsmen have been employed again to look after the towpaths and she has also reported to them the leaking aquaducts in the Village.

6) REPORTS FROM COUNTY AND DISTRICT COUNCILLORS

County & District Councillor Bingham reported that County Council met on the 21st June. Main issues discussed were Train timetable problems, new Health & Safety issues with gully cleansing and finances.

Other points raised were the empty Historical Building in Carlisle

8) GREAT WAR COMMEMORATIONS

Following Councillor Hopwood's discussions with Councillors, Headteacher, Vicar and Kath Hayhurst it is proposed and agreed that on 29th October representatives from the Parish Council. Church, History and Art Society will go to Burton School and help children from Years 5 & 6 to make Poppies that will then be placed on the School railings with names of the 118 men from Burton-in-Kendal Poppies will also be placed on the Church railings to commemorate those servicemen out of the 118 who died. There are also 4 names missing from the list in the Church and it is proposed that a new plaque be made with these missing names and added to the existing list. However this requires approval from the Diocese etc.

Approximate cost for materials etc for this poppy project is £300.

It was agreed that this be on July Agenda for approval. The Plaque would be discussed

at a later date.
