3) MINUTES OF THE LAST PARISH COUNCIL MEETING HELD:

The previous minutes were approved and signed by the Chairman.

4) RECEIVE ANNOUNCEMENTS FROM CHAIRMAN

The Chairman read out the Police Report:

It is lambing season, please make sure your dogs are on leads when crossing open fields via a footpath. Even when under control a loose dog causes the sheep to herd and causes unnecessary upset. This is not only one of the busiest times for farmers but a large chunk of their livelihood. Please keep you dogs on leads during this time.

5) OPEN FORUM

It was reported by a member of the public that the recent public meeting about B4RN (Broadband for Rural North) was very well attended and had a positive outcome.

6) REPORTS FROM COUNTY AND DISTRICT COUNCILLORS

County & District Councillor Bingham updated the Council on various County issues including the AGM of the County Council. There is now a new Conservative Chairperson and a Labour Vice Chairperson and the top bench is made of all female councillors.

Other points included the CC new policy on banning plastic, Children's Services have passed Offsted and also recent snow issues in the County.

14) LENGTHSMAN'S LOG, REVIEW OF ACTION ITEMS AND REPORTS FROM PARISH COUNCILLORS AND CLERK.

- a) Cllr Hopwood informed the Council that her recent idea of requesting a Lollypop person was not going to go ahead.
 Daffodils at the south of the village are doing really well and has requested the council purchase more bulbs to be planted.
- Clir Colyer has done her usual dog mess patrol not much improvement and was even some on the Main Street pavement recently. More signs will be requested from SLDC
- c) Clir Mason-Hornby asked if the highways sign indicating distance can be cleaned and also updated the Council on the B4RN meeting.

- d) Clir Wren went through the recent Playground Inspection Report carried out by SLDC. There are a few small maintenance issues that are required, but there is also an issue with dog mess in the playground too. A report has been received from a resident regarding a missing cover on a mains stop tap in the planted triangle at the junction of Tanpits and Station Lane.
- e) Cllr Rogers updated the Council on various issues including the Council sweeper has been through the village, a litter pick has been carried out and verges repaired and finally Cllr Taylor has cleared a ditch on Vicarage Lane that has made an improvement.
- f) Cllr Nolan updated the Council on the possible Cumbria in Bloom entry, this will probably not be for at least 12 months but still keen to do something. A resident has asked for suggestions from the Parish Council as to what material is best to use to re surface a driveway to alleviate flooding the Main Street. Cllr Nolan to look into various materials.
