1) APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs Rogers, Wren and Isherwood and County Councillor R Bingham and District Councillor T Harvey.

2) DECLARATIONS OF INTEREST AND APPLICATIONS FOR DISPENSATION:

3) MINUTES OF THE LAST PARISH COUNCIL MEETING HELD:

The previous minutes were approved and signed by the Chairman.

4) RECEIVE ANNOUNCEMENTS FROM CHAIRMAN

The Chairman read out the Police Report
Only 2 incidents reported have or relate to the Parish. Both refer to noisy
Cars driving at inappropriate speeds in the village. One received 16th July and the other 28th July.

OPEN FORUM

- a) A resident who attended the recent County Council Flood Forum commented that he was disappointed that although the report was very good there didn't seem to be a definite plan going forward to help improve the problem. He was also surprised as he thought there would have been more residents attending the Parish Council meeting to hear an update.
- b) A resident had asked if there had been a response to problems reported last month from Cocking Yard residents. It was confirmed that the Parish Council correspondence had been acknowledged and followed up.

6) REPORTS FROM COUNTY AND DISTRICT COUNCILLORS

District Councillor Brian Cooper reported that during the recent Overview and Scrutiny Committee Meeting, representatives from Northern Rail were questioned regarding the chaos on the Northern Line. They reported that extra rolling stock will be brought in and problems will be solved by May!.

It was also reported that the Customer Connect service was being completed upgraded and would soon be all computerised.

7) COUNTY COUNCIL FLOOD FORUM UPDATE

A number of Parish Councillors and residents attended the County Council Flood Forum held in Burton Memorial Hall on the 8th August. This meeting was a follow up from the meeting in October 2017. A lengthy document has been produced and handed out to attendees.

A three year time span for allocating funding and implementing the action has been put together. Deadlines for some funding has been missed.

Further information has been requested on the Gullies and the issues in the Square included problems with the Electricity cables damaging the Culvert on the West Side and Gas pipes damaging on the East Side.

It was proposed by Councillor Chris Nolan that a Flood Forum/Committee be formed to include Parish Councillors and residents to keep pressure on the County Council. This was unanimously agreed and an update at the next meeting.
